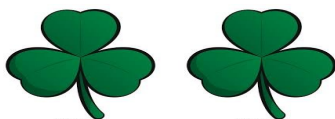

January meeting minutes - Sue Ellen Gary makes a motion to approve the minutes, Ann Perry seconds the motion. Motion carries.

Due for 2026 are to be paid by March 14th to be retained as a member. If you do not pay you will be removed from the roster and will no longer be sent the newsletter.

Treasurer Report: Nancy Church reports that the Raffle account has a balance of \$5,395 and the regular account has expenses of \$446, income of \$1,996 for a balance of \$4,276

Michelle Specht and Kay Denison reported that quilt show entries will be accepted at this meeting and the March Meeting, also Kathy Carlson is accepting entries online. March 14th is the deadline for entries. There will be vendors, and demos. The high school kids will be available to help for setup and the guild will feed them at the Calico Café. Wednesday is the day to check in the quilts, Thursday will be the setup, quilt show will be Friday and Saturday, with take down on Saturday evening and pick up will be on Sunday. Diane Walker asked who could distribute flyers in Paonia, Kitty volunteered to distribute. Nancy got a new sandwich board for the entrance to let people know what is going on each day. Don't forget if you did the challenge quilt there will be a special display for those. Kathy asked you fold the quilts with the colored side out, and to put the tags that you pick up at registration on the lower righthand front corner of your quilt and one tag on the open end of your pillowcase.

Connie Barry is in charge of the Boutique items and she has a lot of items. She will collect any other items at the March meeting, please price your own items and put your initials on them. If your items do not sell please pick them up on Sunday after the show or you can get them at the April meeting. NO EARLY SALES, DON'T ASK! Sales will begin on the first day of the quilt show.

Jean announces that she has enough items for 5 or six baskets. The members are good with having that many baskets at the quilt show. Ann Perry announced that there is still openings for Demos on Saturday if anyone is interested in doing a demo let her know.

By-Laws: Dee thanked all that were on the by-law committee. Connie Barry made the motion to approve the changes to the by-laws; Shirley Bell seconded the motion. Motion carried.

Raffle Tickets: Kitty Julian announces that the raffle tickets are available and to see her if you want to buy or sell raffle tickets. Also please sign up to sell tickets at the 2026 Quilt Show. If anyone has any suggestions of venues to set up at to please let her know. Sue Ellen suggested that we take the raffle quilt to Longmont to the quilt fair there.

April will be Kate Collieran, Zoom Quilt show to be shown at Memorial Hall. Sue Bear will teach the Cabin Blocks class, cost is \$30. The guild pays \$25 per person to the instructor and \$5 goes to rent. If some of the classes that she talked about appeal to you or if you would like to teach a demo please let Nancy know.

Thanks to the food setup committee for February Trish Tuin and Sallie Waldron. March Cally Gallegos and Diane Walker will do setup.

Sunshine Lady Sallie Waldron sent out cards to Sue Poulos, Cheryl Ridgway and Barb Roberts.

Kathy Carlson announced that Barb Roberts will be having an auction February 26,27,28 weather permitting. Her daughter will be selling a couple of sewing machines, if anyone is interested contact Kathy Carlson.
